SUMMARY

Net proceeds from the Share Offer

- Based on the Offer Price of HK\$0.75 per Offer Share and the total number of 170,000,000 Offer Shares, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting commissions and other estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$93.7 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Use of Proceeds” in this announcement.

Applications under the Public Offer

- A total of 13,235 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service for a total of 1,536,728,000 Public Offer Shares, representing approximately 90.39 times of the total number of 17,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to very significant over-subscription in the Public Offer, the reallocation procedures as described in the paragraph headed “Reallocation” under the section headed “Structure and Conditions of the Share Offer” in the Prospectus have been applied. As the Offer Shares under the Placing are oversubscribed and the number of Offer Shares validly applied for in the Public Offer represents more than 50 times of the number of Offer Shares initially available under the Public Offer, 51,000,000 Offer Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 68,000,000 Offer Shares, representing 40% of the total number of Offer Shares available under the Share Offer.

Cornerstone Investor

- Based on the Offer Price of HK\$0.75 per Offer Share, and pursuant to the cornerstone investment agreement, the Cornerstone Investor has subscribed for 33,932,000 Offer Shares, representing (a) approximately 20.0% of the total number of the Offer Shares; and (b) 4.99% of the Shares in issue upon the completion of the Capitalisation Issue and the Share Offer (without taking into account any Shares to be issued upon the exercise of any options which may be granted under the Share Option Scheme). The Placing
